










Introduction

- ➤ Questions about the reliability and comparability of language assessments across different institutions in Burkina Faso.



2. Objective of the study

- ➤ Standardized frameworks like CEFR and ACTFL ensure reliable and comparable assessments globally;
- ➤ Burkina Faso lacks a standardized framework, leading to inconsistent language assessments and impacting teaching quality.

- Burkina Faso's language teaching faces challenges in a multilingual setting;
- ➤ No standardized framework for English assessment;
- ➤ Teachers lack resources, hindering effective teaching;
- ➤ Result: unclear objectives, student confusion, and reduced motivation.

 - Burkina Faso's multilingual context demands a tailored language assessment framework;
 - ➤ This framework should include clear guidelines for assessing various language skills while accommodating the unique multilingual environment.

- ➤ Implement a standardized language assessment framework in Burkina Faso;
- ➤ Integrate established models like CEFR and ACTFL for effective adoption.

- ➤ Organize a dedicated conference in Burkina Faso for framework adoption
